RESTRICTION: ADMINISTRATIVE SUPPLEMENT:

This award provides an administrative supplement in the amount of **\$344,930** total costs (**\$301,509** direct costs + **\$43,421** facilities and administrative costs) to understand the disruptions in mental healthcare due to the COVID-19 pandemic, and its disparate effects on vulnerable patient populations, by examining the paradigm shift to the delivery of services via telehealth dated **5/6/2020**.
